Please read, sign, and return the contract and payment **IN FULL** as stated on the contract. Upon approval, your copy will be signed by the building chairman and returned to you.

**The contract and payment must be received no later than May 15, 2026.** On May 17, 2025, spaces that are not yet rented will become open and filled from the waiting list and then on a first come, first serve basis.

It is Grant County Fair Association's policy that exhibitors **NOT SUB-RENT** any part of the space they have contracted for their use. Any renter donating space to any organization, agency, business, etc. **must notify** the building chairman and submit the same information as was needed for rental for yourself (name, product, location, and person in charge). **THIS IS NEEDED FOR OUR REVIEW.**

**NEW FOR 2026:** Hours that the commercial building are open are as follows: Friday 4:00 pm – 9:00 pm and Saturday 3:00 pm – 9:00 pm.

### **Admission:**

### **Hours:**

The Commercial Building will be open **Friday, June 26 from 4:00 p.m. to 9:00 p.m. and Saturday, June 27 from 3:00 p.m. to 9:00 p.m.** Later or earlier closing is at the discretion of the building director. The building will be locked from 10:00 p.m. until 2:45 p.m. the next day during the fair week. Guards will be on duty all night.

### **Setup:**

**Setup time will be on FRIDAY, JUNE 26 beginning at 8:00 a.m. – 1:00 p.m.**

**EXHIBITS MUST BE READY AND SETUP MUST BE COMPLETED BY FRIDAY, JUNE 26 AT 4:00 P.M.**  
**THERE WILL BE NO EXCEPTIONS!**

### **Removal:**

Exhibits must be removed after closing on **Saturday, June 27**, or over the next day (Sunday). **Exhibits left after Monday, June 29, 2026 will be disposed of.** GRANT COUNTY FAIR ASSOCIATION IS NOT LIABLE FOR EXHIBITS WHILE THEY ARE ON THE FAIRGROUNDS. No exhibits may be stored in the building from fair to fair.

### **Clean up:**

Aisles will be swept as needed, after hours, by a building attendant. We ask that before leaving your booth for the night that you sweep up around your area and push it into the aisle. Your cooperation helps keep the building and booths attractive.
