

GRANT COUNTY FAIR ASSOCIATION
INSIDE STORAGE/RENTAL AGREEMENT - 2019-2020

ALL STORED ITEMS NEED TO BE REMOVED FROM THE BUILDING **SATURDAY, APRIL 11, 2020 AT 8 AM.** ITEMS NOT PICKED UP BY NOON ON **APRIL 11** WILL BE SET OUTSIDE THE BUILDING AND A HOLDOVER CHARGE IMPLEMENTED. THE GRANT COUNTY FAIR ASSOCIATION **WILL NOT BE RESPONSIBLE** FOR ITEMS LEFT OUTSIDE AFTER NOON ON THE 11 OF APRIL. AN INCLEMENT WEATHER DATE WILL BE SET FOR THE FOLLOWING SATURDAY.

LESSOR NOT RESPONSIBLE FOR FIRE, THEFT, OR DAMAGE TO ANY STORED EQUIPMENT OR THEIR CONTENTS UNDER ANY CIRCUMSTANCES. SIGNING THIS AGREEMENT RELEASES THE GRANT COUNTY FAIR ASSOCIATION AND THEIR REPRESENTATIVES FROM RESPONSIBILITY TOWARDS THE STORED EQUIPMENT.

This agreement entered into by and between the GRANT COUNTY FAIR ASSOCIATION, hereinafter referred to as "lessor" and _____, hereinafter referred to as "lessee",

WITNESSETH

For the consideration of the terms, conditions and covenants set forth herein, Lessee agrees to and does hereby lease from Lessor the following facilities of Lessor for storage purposes: **Commercial Building**

Boat, car, trailer, other vehicle or equipment. **Total length of item at \$10.00 per foot of length (Including hitches, bumpers and tongues).** Articles must be removed from the premises by APRIL 11, 2020.

Lessee agrees to pay a holdover charge of \$5.00 per day on each piece of equipment left at the fairgrounds after April 11, 2020. This will be strictly enforced.

PLASTIC SHEET OR SIMILAR MATERIAL, PROVIDED BY LESSEE, MUST BE PUT UNDER EACH VEHICLE WHERE FLUIDS MAY LEAK TO PROTECT THE FLOOR
PROPANE TANKS AND OTHER FLAMMABLES MUST BE REMOVED BEFORE STORAGE

If any action is brought by either party under this agreement arising out of or in connection with this agreement, the successful party shall be entitled to reasonable attorney's fees and costs.
